



TERMS & CONDITIONS

TERMS AND CONDITIONS PROPER LOADING: In accordance with Michigan law, yard waste, tires or white goods cannot be mixed with other waste. Customer shall not load these items into container unless special arrangements have been made with hauler. If container is improperly loaded, customer will be responsible for unloading container to meet these requirements. Any material left behind due to improper or excessive loading will be the customer's responsibility. Customer shall not place any corrosive, flammable, explosive, potentially infectious or other hazardous wastes in or proximity to container. Any hazardous wastes will be refused or returned at customer's expense.

LIABILITY: TNT Disposal will take every precaution when delivering our containers. Hauler assumes no responsibility for damage to driveway, sidewalk, curb, yard, parking lot or accompanying sub-surface at point of service where directed by customer. Customer warrants the right of way provided by customer to point of service from the most convenient public way that is sufficient to bear the weight of the haulers equipment and vehicles reasonably required to perform the service herein contracted. Additionally, Customer expressly agrees to defend, indemnify, and hold harmless Contractor from and against any and all claims for loss of or damage to property to injury to or death of person or persons resulting from or arising in any manner out of Customer's use, operation or possession of any equipment furnished under this Agreement.

MISCELLANEOUS: Customer is responsible to secure/provide any permits, barricades or other devices required by law to place container at point of service. Customer shall be responsible to maintain access to Contractor's equipment, keeping path to equipment clear of all obstacles, including parked cars. Customer shall not use container for incineration purposes and shall be held liable to hauler for loss or damage in excess of reasonable wear and tear. Customer agrees to defend, hold harmless and indemnify hauler against all claims, lawsuits, and any other liability for injury to persons or damage to property arising out of the possession or use by the container by customer.

PAYMENTS: Customer agrees to make payments for any and all charges contained herein. If a credit card is initially used for payments, customer agrees to allow TNT Disposal to charge subsequent charges and fees contained herein to the credit card. Customer agrees to make immediate payment for all fees and charges and to pay 1.5% monthly interest and all attorney fees, court costs, and lien processing fees for past due balances. Payment is due at/before dumpster drop off Payment for 'other fees' is due upon receipt We accept Cash, Check, Card, Venmo & PayPal.

OTHER FEES: Fees may be avoided by ensuring proper loading and care is taken with the Dumpsters.

- Outside of 20 Mile Delivery Radius - \$2.50/ per mile
- Weight overages - \$60/per ton
- Mattress/Box Spring - \$25
- Tires - \$10/each
- Tube televisions - \$50
- Additional rental days - \$15/per day
- Unauthorized moving of dumpster: \$200
- Unloading Overloaded Dumpsters: \$5 per minute, 30 minute minimum
- Unable to Retrieve Dumpster: \$150 – This includes but is not limited to, blocked and/or overfilled dumpsters
- Damaged Dumpster: Full replacement cost of dumpster at current market prices + unloading costs + delivery costs.
